APRN Task Force:

Merilyn Douglass, speaker for Task Force discussed the proposed draft language for the nurse statutory proposal from the APRN Task Force. The conclusion of the Task Force was to 1) add into the draft language a requirement of certification for the APRN Nurses to insure confidence for the APRN Nurses and 2) to remove statement on signing death or birth certificates. This statute belongs in Vital Statistics 3) keep requirement for proof of malpractice insurance except for employees of federal agencies which are covered by the tort claims act.

Also discussed was 1) to remove language that describes a collaborative practice agreement with physicians and 2) to remove collaborative practice agreement to prescribe medication pursuant to protocol.
