It was moved to accept Baker University's revised philosophy, program/level/course outcomes, course descriptions, course titles and content, credit hours in 2 courses and program credit hours (to 64) credits. Motion #31 Pomatto/Hiner. Adopted UYVV. One abstention Bernard Becker.

It was moved to accept Bethel College's request to move the NSG 305 Pathophysiology course to BIO 305 with the course becoming a pre-requisite to the program in 2011 & 2012, combine 3 medical-surgical nursing courses (Care of the Adult, Perioperative Nursing and Gerontological Nursing) into Care of the Adult Client I and Care of the Adult Client II; increase nursing Pharmacology from 0.5 credit hour to 1.0 credit hour per semester totaling 4 credit hours of Pharmacology for the nursing curriculum; increase hours for NSG 320 Clinical Practicum I from 3 to 4 hours; decrease the number of credit hours for Nursing 401 from 3 to 2 credit hours; change course description and objectives for NSG 418 Complex Care of Adult Client; increase NSG 417 Management from 2 credit hours to 3 credit hours & change in delivery method for Clinical Practicum IV from a traditional practicum to a combination traditional plus capstone experience with approved preceptor format. It was moved to accept Washburn University School of Nursing's proposal to eliminate NU 518 Advanced Nursing Research 3 credits from the MSN curriculum & replace it with NU 517 Clinical Scholarship for EBP 3 credits & accept the change in Washburn University's course sequence of NU 603 & re-titling with minor revisions to pre-requisites for NU 600, 602, 606 & 608, and to approve Washburn University's request that NU 477 Nursing III Practicum be eliminated from the BSN curriculum & be replaced with 2 courses NU 476: Adult Medical Surgical Nursing Practicum III (4 credits 180 practicum hours) and NU 441: Adult Medical Surgical Nursing III: Integrative Seminar (1 credit hour & 30 practicum hours). Motion #34 Pomatto/Stutzman. Adopted UYVV.

It was moved to approve proposal from Pratt Community College to adopt a modified version of the Kansas PN Core Curriculum including extension of program into the summer & offer on-line delivery of PN level & increase the number of students by 20 from 70 - 90.
