APRN Roundtable Update: Jane Symmonds gave a review of what was discussed at the APRN Roundtable. No new information. Continue to discuss independence and prescriptive authority. Several states working on moving CNS into advance practice as some states don't recognized CNS as advance practice. The APRN Roundtable is still working on trying to move into the consensus model.

AD Hoc/APRN TASK-Force Committee Update:

Brenda Moffitt was the chair for the Ad Hoc/APRN TASK Force Committee and gave an update. The committee met in person on May 29, 2013 in the library at the Kansas State Board of Nursing office. The committee went through the APRN language and Brenda felt progress was made. Several items were discussed: 1) transition to practice hours; 2) malpractice insurance; 3) national certification and 4) certification exams.
