Legislative review of Statutes/Regs 60-11-118 – Discussed issues related to including
language to provide a temporary permit for completion of a
refresher course and the issues created when someone
who has not been previously had a certificate of
qualification in Kansas needed to take a refresher course.
Patty will investigate issues related to providing a

temporary permit for the completion of a refresher course and bring to the June meeting.

60-13-104 Discussed the review of the exam content – will put on the June agenda; Tom pointed out that the regulation should read the “Council on certification” rather than accreditation. The draft will be revised for action at the June meeting
