    - Patty announced that the Opt out was signed March 31 and an article will appear in the next newsletter along with a letter received from KANA; copies of an article that appears on the ASA website related to independent practice of CRNAs was made available.
    - Patty reported that the statistics in the FY 2001 annual report on the number of ARNPs was erroneous due to a computer calculation of the totals; FY02 data was hand counted and is correct in the FY02 annual report available on the web site.
    - Patty reviewed the information received from various certifying agencies and made available copies of the notes she took at the NCSBN APRN Roundtable April 10, 2003
    - Patty reported that 60-11-103 includes a reference to 60-11-108 (revoked education regulation) and 60-17-111 outlining the refresher requirements indicates that individuals have been licensed as an ARNP to be eligible which presents problems for those who completed the approved requirements more than 5 years ago but did not previously seek ARNP recognition.
    - Diane Okeson announced she will not be seeking an additional term on the board due to family reasons and thanked the committee for the opportunity to work with them
