## New Advance Practice Statutes Effective January 1, 2012


During the 2011 legislative session several changes were made to the Advance Registered Nurse Practitioner statutes. The following changes will go into effect on January 1, 2012

1. Title change from Advance Registered Nurse Practitioner (ARNP) to Advance Practice Registered Nurse (APRN). By changing the title, it will establish uniformity with other states in the nation and will be less confusing to APRNs who come to Kansas for licensure.
2. Change certificate of qualification to licensure. Certification is granted to an APRN by an accrediting agency when they have completed specialty education. KSBN licenses LPN, RN, and LMHT so this would provide consistency in our process. Also, licensure is one of the four essential elements of the Consensus Model.
3. Changes categories of APRN to roles. The roles will continue to be the same as currently in statute. Those four roles are: Clinical Nurse Specialist, Nurse Anesthetist, Nurse Midwife, and Nurse Practitioner.
4. Require a Masters or higher degree in an APRN roll. This change in the statute

will align Kansas with other states in the nation. All APRN programs in Kansas confer a Master degree upon graduation.

5. Continuing education in the APRN role. Presently ARNP are only required to have continuing nursing education hours every two years in the RN role. Although APRNs usually obtain the hours in the advanced role, this will now require them to receive advance practice continuing nursing education.
6. Any ARNP who is registered to practice prior to the effect date of this bill will be deemed to be licensed to practice as an APRN without being required to file an original application for licensure to remain in practice.

The Board of Nursing has reviewed the ARNP regulations and has incorporated the statute changes and determined the number of continue nursing education hours needed for renewal. The regulation changes are currently going through the review process by other state agencies. After the review process is complete, the Board of Nursing will hold a public hearing on the proposed changes. **Please monitor [www.ksbn.org](http://www.ksbn.org) for a copy of the proposed regulations and date of the hearing.**

# Focus on Statutes/Regulations from the Kansas Nurse Practice Act

**65-1120. Grounds for disciplinary actions; proceedings; witnesses; costs; professional incompetency defined; criminal justice record information.**

(a) Grounds for disciplinary actions. The board may deny, revoke, limit or suspend any license, certificate of qualification or authorization to practice nursing as a registered professional nurse, as a licensed practical nurse, as an advanced registered nurse practitioner or as a registered nurse anesthetist that is issued by the board or applied for under this act or may publicly or privately censure a licensee or holder of a certificate of qualification or authorization, if the applicant, licensee or holder of a certificate of qualification or authorization is found after hearing: ...

(6) to be guilty of unprofessional conduct as defined by rules and regulations of the board;...

**60-3-110. Unprofessional conduct.** Any of the following shall constitute “unprofessional conduct”:

(a) Performing acts beyond the authorized scope of the level of nursing for which the individual is licensed; ...

In the regulatory practice realm we often see cases involving a violation of this regulation. The typical violations involve an LPN that is practicing without supervision, an LPN performing an IV therapy task that is prohibited, an RN/LPN/APRN that is providing medical treatment without an order/protocol/collaborative agreement to do so or an RN that is crossing into the protected practice of an APRN. Not only can a nursing license be disciplined for a violation but in a civil malpractice action if it is proven that a nurse is functioning outside of the lawful scope of practice an insurance company can deny coverage for the act and a plaintiff is almost assured a judgment in their favor. It is very important for licensees to understand and stay within their scope of practice that is authorized by statute. Nurses should remember also that the authorized scope of practice varies from state to state. What is allowed in one may not be allowed in another. Nurses should always study and know the scope of practice for any state in which they are working.

## Approval of Continuing Education

In order to receive credit for continuing education each presentation or provider must be approved by the Board. Many presenters have been pre-approved by the Board and their presentations will be accepted. Approved presenters have a number on their certificates of attendance such as: "SP1111-1234" or "LT0555-1234." If the provider has not received pre-approval for their presentation, it will be necessary for the licensee to fill out and return an IOA (Individual Offering Approval) form.

A note of caution concerning IOAs...**When license renewal is done using CNE which needs an IOA, the IOA must be approved by the Board BEFORE renewing the license.** An IOA form must be completed for those offerings attended that have not been approved for continuing nursing credit by a national nursing organization or a state board of nursing.

The offering objectives and agenda **MUST** be sent with the IOA form to receive credit. A copy of the certificate or verification of attendance must be attached, with a Self Addressed Stamped Envelope (SASE)

If the IOA is not approved prior to license renewal, it cannot count towards the 30 hours and your license renewal may be placed in jeopardy.

## June 2011 CNE Newsletter

The following items are from the approved minutes of the June 2011 CNE committee:

1. The following long term CNE providerships were granted renewal for 5 years: Salina Surgical, The Lemon's Center, Mercy Regional Hospital, Community HealthCare System, Blue Valley Schools Student Services, Fort Scott Community College, Heartland Surgical Specialty Hospital, Case Management of America – Kansas City.
2. Axelacare Health Solutions, Inc. initial application was approved for a long term CNE providership.

To date, there have been 33 applications approved for Single Offering CNE Providerships since the first of the year.

Presently there are 140 approved Long Term CNE Providerships. The list on the website has been updated.

New regulations for the IV Therapy for practical nurses have been drafted and submitted to the Department of Administration and Attorney General's office for review. After those offices approve the proposed regulations, they will be published for public comment. The major change for the proposed regulations would allow approved IV Therapy providers to design a curriculum which will teach the IV Therapy students to meet the February 2011 standards published by the Infusion Nurses Society.

## June 2011 ARNP Newsletter

The following items are from the approved minutes of the June 2011 ARNP committee:

1. The APRN bill has passed and has been signed by the governor. Some of it will become effective July 1, 2011. APRN Statutes become effective January 1, 2012. Important points of the bill are as follows:
  - a. Changing ARNP to APRN
  - b. Certification changes to licensure
  - c. Certification of qualification will become Temporary Permit
  - d. Categories will be called Roles
  - e. The statute will require a Master's of Science in Nursing.
  - f. The existing advanced practice nurses are grandfathered in, so they are not required to take any steps to stay licensed as a result of the change.
  - g. Applications already submitted for certification are considered applications for licensure.
  - h. CNE will be required for advanced practice nurses in their role.
2. It was moved to approve the following schools from out of state:
  - a. University of Maryland – Baltimore
  - b. Prairie View A&M Texas – FNP
  - c. University of Nevada Reno – FNP
  - d. Raleigh U. of North Carolina – RNA
  - e. Rush – Chicago – RNA
  - f. MGH Institute of Health Professions – FNP
  - g. Ball State University – FNP
  - h. University of Nebraska – Adult NP
  - i. Samford U, Birmingham AL – RNA
  - j. Indiana State University – FNP
  - k. Pacific Lutheran University – FNP

New regulations for the Advanced Practice Registered Nurse law have been drafted and submitted to the Department of Administration and Attorney General's office for review. After those offices approve the proposed regulations, they will be published for public comment. The major change for the proposed regulations is to establish language for the continuing education requirement for advance practice which is similar to existing language for the existing RN continuing education requirements.

## APRNs and Sports Physicals

Each year KSBN receives numerous questions about the Kansas State High School Activities Association's Pre-participation Physical Evaluation (PPE) and who is allowed to perform these physicals. The KSHSAA will only accept physicals signed by a physician. They consider physicals signed by APRNs and bearing the physician's stamp/signature to have met that requirement as it reflects physician oversight and a guarantee of the availability of malpractice insurance. While this practice is more restrictive than the statutorily authorized practice of nursing the KSHSAA is allowed to make that choice. There stated policy behind that restriction is based upon liability concerns as APRNs are not always practicing with physicians and are not required by law to carry malpractice insurance. They do accept PAs signatures because PAs are not authorized to practice independently and being employed by physicians they are covered by the physician's malpractice insurance.

In general the Kansas Nurse Practice Act allows nurses to perform head to toe physicals on individuals. RNs, LPNs and APRNs without authorizing collaborative practice agreements are only able to make findings in terms of normal versus abnormal or in stated nursing diagnoses terms. APRNs with authorizing collaborative practice agreements are able to assign medical diagnoses. As in the scenario above any employer can choose to narrow the statutorily authorized scope of practice so nurses need to familiar with policies and procedures of the business. Many times restrictions are driven by liability requirements.

## Investigative Committee

The Investigative Committee met on Monday and Tuesday September 12th and 13th. Approximately 100 cases were reviewed and dispositions were directed. On Tuesday morning the general session was held. Information on the changes implemented by KNAP's program was shared. The new HAPN Director for nursing issues Regena Walters was present and was introduced to the committee. In December the committee plans to consider a change to the discipline statute making revocations of licenses permanent and listing of imposter information on the website.

## Practice Committee

The Practice Committee met on Tuesday September 13th. The discussion on the LMHT statutes and regulations continued. The request to consider a scope of practice change was reviewed. The request was to broaden the scope to include care of head injuries and drug/alcohol treatment. The committee felt that in light of the fact that there are only 130 LMHTs left and the fact that the request would probably not pass the KDHE Credentialing scrutiny that work should continue on repealing statutes and regulations dealing with LMHT education and testing. Draft changes will be brought to the December committee meeting for consideration. IV therapy regulation updates and changes were also reviewed and discussed.

## June Finance Committee

The June Finance Committee was called to order June 15, 2011 at 8:30 a.m. in room 108 of the Landon State Office Building in Topeka by Bernard Becker, Vice Chair. The agenda was amended to add end of fiscal year 11. The minutes from the March 30, 2011 meeting were approved.

M. Blubaugh reported that the FY11 budget was increased by \$48,000 as requested and the agency received the 3 positions that eliminated in the Governors recommendations. She reported that the FY 12 budget was cut across the board by \$7,356, \$14,339 from IT and \$1,044 on cell phones. The FY 13 budget was \$2,109,810 as requested. M. Blubaugh reported that the amount KSBN contributes to the State General Fund was decreased from \$200,000 to \$100,000.

Increasing the licensing fees was discussed. It was the consensus of the Finance Committee to take the fee increase to the full board in September. A. Guerrero discussed and requested that KSBN purchase an upgrade to ImageNow so the images from the online renewals will be captured from the e-gov system to ImageNow without a staff person processing them individually. The cost was estimated to be between \$10,000 and \$12,000. It was the consensus of the Finance Committee to take the request to the full Board.

The meeting was adjourned at 9:02 a.m.

## Fingerprinting by Appointment

Fingerprinting for background checks may now be processed using an electronic system at the KSBN office. Walk-in printing may be done but due to equipment and staffing limitations it is highly suggested that an appointment be made for having your fingerprints taken. There are occasions when all of the equipment will be in use out of the office. By calling ahead and scheduling an appointment you may eliminate frustration occurring from driving to the office then being rerouted to our local KBI office.

Fingerprints will only be taken if an application has been received. The fee for having your fingerprints done in our office is \$7.50 which may be included in the same check/money order as the \$50.00 background fee. If you are delivering an application at the same time, the application fee may be included in the same check/money order. Cash is accepted in our office for the exact amount; we do not have the ability to make change. Appointments for walk in printing will not be accepted after 3:30 pm. ## June 2011 Education Committee

The Education Committee met June 14, 2011 and was called to order by Mary Carol Pomatto, Chairperson, at 8:35 a.m. in Room 106 of the Landon State Office Building. The Committee reviewed the onsite packet and approved the additions and revisions to the agenda. The minutes from March 29, 2011 were approved. The Education Specialist report was given by Carol Moreland. Mary Blubaugh introduced Rebecca Nioce, new Public Board Member.

Cloud County Community College ADN Program had a site visit on March 1-3, 2011. It was moved to accept the site visit report for Cloud County Community College and recommendations for re-approval for eight years. Baker University BSN Program had a site visit on March 28-30, 2011. It was moved to accept the site visit report for Baker University and recommendations for re-approval for ten years. Kansas City Kansas Community College PN Program had a site visit on April 5 & 6, 2011. It was moved to accept for site visit report for Kansas City Kansas Community College PN Program and recommendation for re-approval for five years. Wichita Area Technical College PN Program had a site visit on April 27 & 28, 2011. It was moved to accept the site visit report for Wichita Area Technical College and recommendations for re-approval for five years.

The Fall 2011 Nursing School site visit schedule was discussed. The LMHT Survey results from Arkansas, California and Colorado was reviewed. Feedback from 2010 NCLEX RN pass rates from Colby Community College, Brown Mackie College – Kansas City Camps and Garden City Community College were discussed. Feedback from 2010 NCLEX PN pass rates from Donnelly College was discussed. The Southeast Kansas Nursing Education Collaboration presented an update on their collaborative effort to develop a library of resources for instructors in three areas of mental health. The Western Kansas Clinical Collaborative presented an update on their pilot at Hays Medical Center involving Dedicated Educated Clinicians, a new clinical model.

Ten petitions for permission to test/retest were reviewed and action taken.

The meeting was adjourned at 11:35 pm.

**What is KNAP?**

KNAP is a professional assistance program designed to assist all nurses and mental health technicians who have a problem or illness that has or could impair their ability to practice safely.

**The Goal of KNAP**

Mental and physical illness, including alcohol and other drug addiction, can potentially impair practice and health. We estimate that at any given time, approximately 10% of the population is affected. This same percentage is thought to be true of healthcare professionals.

Alcohol and other drug addiction, as well as mental and physical illnesses, are treatable. KNAP works with the program participants to obtain an evaluation, treatment (if indicated), and monitoring throughout the recovery process.

**Referrals**

Self-referrals to the program are encouraged, but referrals may be made by a family member, a friend, employer or anyone concerned about the nurse/LMHT.

Anonymous referrals are not accepted. A person may call for information or advice without giving their name, however. Referrals may be made by calling 913-236-7575.

**KNAP Providers**

- Confidential services to Kansas RNs, LPNs, and LMHTs experiencing problems and illnesses which could lead to impaired practice.
- Interventions, assessments, referrals for evaluation and treatment (if indicated.)
- On-going monitoring through random urine drug screens, contact with employers and monthly groups.

**Causes for Concern****Job Function**

- Narcotics discrepancies, e.g.: incorrect counts, alteration of narcotic containers, increased patient reports of ineffective pain control, discrepancies on records or frequent corrections of records, unusual amounts of narcotics wasted, significant variations in the quantity of narcotics ordered for technician's unit or shift.

- Fluctuations in the quality of work performance.
- Irresponsible behavior from someone previously conscientious and responsible.
- Requests to work shifts that are the least supervised.
- Inordinate interest in patients' pain control medications.

**Behavior**

- Increasing isolation from colleagues, friends and family and avoiding social activities.
- Complaints from others about work performance or alcohol or drug use.
- Mood swings, irritability or depression, or suicide threats or attempts, perhaps caused by accidental overdose.

**Physical Symptoms**

- Obvious intoxication such as swaying, staggering or slurred speech.
- Odor of alcohol on breath or the excessive use of breath-fresheners or perfume to disguise the odor of alcohol.

KNAP is supported by funds from the Board of Nursing and, in small part, by fees charged to the participants.

## Helping Patients Who Are Victims of Domestic or Sexual Violence

In January 2007, Kansas began offering the Safe at Home address confidentiality program to victims of domestic violence, sexual assault, human trafficking and stalking. This program is administered by the Secretary of State's office, and currently more than 230 victims have enrolled for this service. As health care professionals, you may be the first point of contact for a victim who could benefit from this program. You may recommend it to a patient in need, or a victim may ask you to provide documentation that he or she can use as evidence to qualify for Safe at Home.

Modeled after similar programs in other states, Safe at Home provides a substitute address for victims, as well as a free mail forwarding system for all first-class mail. Safe at Home allows qualified program participants to use this substitute address on all public records in lieu of the residential address required by many other Kansas laws. For many victims of these crimes, Safe at Home allows them to interact on a normal basis with all levels of government, rather than fearing that government records will put their lives in danger.

Potential participants must apply for certification in the Safe at Home program through

enrolling agents, which are usually organizations that offer shelter or counseling services to these victims. These enrolling agents have designated staff that help victims through the application process and help them develop safety plans. When applying for Safe at Home, applicants must provide contact information, including their actual physical address, as well as evidence that they are a victim of one of the qualifying crimes.

Once certified in Safe at Home, participants are able to use the substitute address—a post office box in Topeka—on all of their records with state and local agencies. Participants are issued a participant card that can be shown as proof of certification in the program. All first-class and certified mail received at the post office box is forwarded to the participants at no cost. Safe at Home also accepts service of process for participants.

Safe at Home is a valuable resource in protecting victims of domestic violence, sexual assault, human trafficking and stalking. Used in cooperation with a safety plan, victims may now feel safer in their homes and daily lives. # Frequently Asked Questions Now Updated!!!

KSBN has recently completed updates to our Frequently Asked Questions (FAQ's) on our website. Below is a sampling of some FAQ's which are located under the Renewal questions section. A selection of questions will be printed in future editions of this newsletter. Please refer to our newly updated FAQ's for answers to your questions.

**Q: Will the CNE provider send my 30 hours to KSBN?**

A. No, you are responsible for submitting your original certificates to KSBN.

**Q: What is meant by approved CNE?**

A: CNE providers approved by any state Board of Nursing or any nationally recognized Nursing organization such as ANCC or AANA or a course approved through the individual offering approval (IOA) process.

**Q: Can I submit my IOA form with my paper application or after I renew online?**

A: No. All CNE must be completed and approved prior to submitting your renewal. Once you receive your approved IOA form you may complete your online or paper renewal application.

**Q: I want to place my license on Inactive status. How do I do that?**

A: You may only place your LMHT, LPN, or RN license on "Inactive" status by submitting a paper "License Renewal Application" completed according to the special instructions for an "Inactive" license. ARNP licenses may not be placed on "Inactive" status.

**Q: After renewal, when will I get my license card?**

A: As of July 1, 2010 we discontinued printing license cards for license renewals. You may go to "Check Status of Application" to review your expiration date and other aspects of your license.

**Q: How long do I have to renew my license after I let it lapse?**

A: You may only "Renew" an "Active" license. You may "Reinstate" your license up to five years after you have held an active without having to complete a refresher course.

**Q: How can I find out what date my license was reinstated?**

A: Submit an "Information Request" form found in the "Forms" section of our website. List specifically what information you need and mail the form to our office. A fee may be applied.

**Q: How do I renew my Inactive status?**

A: Prior to your expiration date, print the License Renewal Application from the Forms section of our website. Send in completed application with the \$10.00 fee. You will NOT receive a license card and you will need to renew your Inactive status again in two years.

**Q: I received my Notice of Renewal Application for my RN but not my ARNP.**

A: Notice of Renewal Applications are only mailed out for LMHT, LPN, & RN licenses. The advance practice licenses will be renewed automatically with the RN license.

**Q: Since the Notice of Renewal Application does not include the fee, how can I find cost of renewal?**

A. Access the KSBN website.

**Q: This is the first time I renewed online. What is my UserID and Password?**

A: You must create a **UserID** and **Password**. Click **Register a Person** and follow online instructions.

**Q: I want to renew both my RN and ARNP online but the system only allows me to renew the RN?**

A: Your ARNP license is automatically renewed with your RN license.

**Q: I was renewing online and got to the screen where it lists my license(s), but it won't let me go any further.**

A: On the "Application for License Renewal" screen you must click on the word "Continue" within the profession you are trying to renew.

**Q: I was just issued an ARNP license that doesn't expire for another two years. Can I renew my RN online?**

A: Because the ARNP is tied in with the RN license you should print out the paper "License Renewal Application" and mail it in to get your RN and ARNP expiration dates in sync with each other.

**Q: How do I know if I am required to have CNE for my renewal?**

A: If it has been over 30 months since passing the NCLEX or over 9 months since receiving licensure by endorsement or reinstatement, 30 hours of CNE will be required.

**Q: I meant to renew my license last month but I did not get it completed. How can I renew now since the system won't let me renew online?**

A: You must now complete a paper reinstatement application.

**Q: Once I Renew online how long do I have to complete my CNE?**

A: Your 30 hours of approved CNE must be completed PRIOR to submitting your application.

**Q: What is meant by approved CNE?**

A: CNE providers approved by any state Board of Nursing or any nationally recognized Nursing organization such as ANCC or AANA or a course approved through the individual offering approval (IOA) process.

**Q: My license expired at the end of last month, what should I do?**

A: Print and complete the Reinstatement Application from the Forms section at [www.ksbn.org](http://www.ksbn.org).

**Q: I went to Check Status of Application and noticed a License Number assigned to me. When will I get my card?**

A: License cards for new licensees are printed at least weekly.

**Q: I just got my license card but there is no expiration date on the card. When does my license expire?**

A: The expiration date shall be the last day of the month in which the licensee's birthday occurs and will be an odd or even year depending on which year you were born in. A license expires every two years. Refer to our License Verification Database at [www.ksbn.org](http://www.ksbn.org) to see when your license expires.

**Q: How do I answer the question about CNE if I am renewing my license for the first time after passing the NCLEX exam?**

A: If it has been less than 30 months since passing the NCLEX exam, you are not required to obtain CNE. You should answer no. If it has been more than 30 months and you have completed approved CNE you should answer yes.

**Q: What happens if I renew and have not obtained 30 hours of approved CNE?**

A: You may be disciplined.

**Q: What proof do I need that I completed my CNE?**

A. Original certificates of completion from approved providers. Certificates must contain a provider ID number from a recognized Nursing CNE provider. Examples of acceptable providers are KSBN IOA form; CNE providers approved by any state Board of Nursing or any nationally recognized Nursing organization such as ANCC or AANA.

**Q: How do I know the Continuing Nursing Education I completed is approved?**

A: Check the accreditation and/or approval on all courses that you complete. KSBN will only accept Continuing Nursing Education that is approved or accredited by Nursing providers. Examples of

acceptable providers are KSBN IOA form; CNE providers approved by any state Board of Nursing or any nationally recognized Nursing organization such as ANCC or AANA.

**Q: Do college classes count for Continuing Nursing Education?**

A: Not all college courses count for Continuing Nursing Education. College courses in science, psychology, sociology, or statistics that are prerequisites for a nursing degree may qualify. If you would like to use your college courses for Continuing Nursing Education credit you must complete the Individual Offering of Approval (IOA) form. This process must be completed PRIOR to using a college course for renewal or reinstatement.

**Q: I have acquired many Continuing Nursing Education hours that are less than 1 contact hour. Can I use those for Continuing Education hours?**

A: No. KSBN will not accept Continuing Nursing Education that is less than 1 contact hour.


**Q: Can I fax Individual Offering Approval?**

A: No, you must mail the original IOA form along with a self addressed stamped envelope and other items as noted in the instructions for completing the IOA form.

**Q: Can an employer narrow a nurses scope of practice and is a nurse bound by that?**


A. Yes. Even though the legislature and Board through statutes and regulations set a wide scope of practice for nurses, an employer can choose what they will and won't allow a nurse to do. A nurse is bound by the facility policy and procedure. K.S.A. 65-1120(a)(6) unprofessional conduct is a ground for discipline of a nurses license. At K.A.R. 60-3-110(c) unprofessional conduct is defined as failing to follow policies and procedures in the practice situation designed to safeguard the patient. You must know and follow your facility policy and procedures unless you believe it is clearly substandard.






